Dear Members of the Brookline Interim Superintendent Selection Committee,

I have served 29 years as a public school educator in the state of Massachusetts. 22 have been as a school administrator, 16 of which have been as a Superintendent. It has been my privilege to work for the school districts of Lincoln-Sudbury, Wellesley, and Natick and with the supporting communities of those school districts. Not only am I deeply experienced in the role of Superintendent across different types of school districts I have served previously as an Interim Superintendent which provides its own nuance to the responsibilities of the Superintendent. In that case one must ensure a district is doing its best to meet the needs of all of its students while making progress on the long range goals of improvement it has set for itself and lay the appropriate groundwork for a smooth transition to permanent leadership.

I have spent some time reviewing recent media reports about the school district and watching School Committee meetings recorded since November of the current academic year. Starting July 1, the district will be undergoing a significant transition in leadership in the central office and schools across several roles and will welcome new members to the School Committee while it must address challenges to assure effective long range planning and programming for the benefit of its students with all due speed. What happens in a School Committee meeting is removed from the heart of learning that takes place in classrooms across the district. However, I am impressed by the passion of the many speakers that made the time to attend the meetings and the deliberate patience of the members to listen and consider every statement that was made about the schools.

Assuming the responsibility of being the Interim Superintendent for the Brookline Public Schools at this time will be a daunting task for anyone to try. To succeed will demand that all community members across the district and town will need to cooperate and collaborate. To problem solve effectively will require honest self reflection in order to move forward with greater understanding and clarity.

I am interested in the challenge the role presents. I am also personally interested as a proud alumnus of the school system. The schools made such a positive impact on my life and it is why I became a public school educator myself. Until the passing of my father last July my family has lived in Brookline since 1967.

It is my sincere pleasure to submit this application for your consideration.
